  3. BRIEFING ITEM: Map Submittal Update
    - ARCBridge Consultants provided an update on the total number of maps submitted to-date related to the redistricting process.

  4. BRIEFING ITEM: Map Overlays
    - ARCBridge Consultants provided an overview of the requested map overlays that were being added to the Redistricting website for reference purposes during the map drawing and submission process.
    - General questions were asked by the Commission related to the overlays demonstrated by ARCBridge.
  5. BRIEFING ITEM: Boards and Commission Procedures
    - Laura Morrison, Assistant City Attorney, provided a presentation on the applicable procedures to the Redistricting Commission as part of Section 8, including general decorum and order requirements.
  6. BRIEFING ITEM: Redistricting Marketing
    - Catherine Cuellar, Communications, Outreach, & Marketing Director, provided a brief overview of a memorandum provided to the Commission in advance. The memorandum provided an update on the marketing and outreach strategy for the Redistricting Commission to-date.
    - General questions were asked by the Commission related to the marketing strategy utilized to-date and looking ahead to the future.
  7. DISCUSSION ITEM: District Reports
    - Chair Jesse D. Oliver briefly touched on the District Reports discussed in a previous meeting and reiterated the fact that these reports were voluntary, and that time would be set aside for any commissioner who wished to create a report and present on their district.
