
- The Commissioners are encouraged to review all map plans that have been submitted for the week, as some submitters may decline to present.

#### Map Submittal Update – COD-020-Minnis



- Max Dev 8.01%
- # of Minority Districts 9
- NH-Black 3
   (3, 4, 10)
- Hispanic 6
   (1, 2, 5, 6, 7, 8)
- Districts 1, 2, 3, 8, 10, 12 and 14 have low compactness scores
- # of neighborhood associations split – 53 out of 443





NH White – Yellow; Hispanic – Red; NH Black – Blue

## Map Selection Process & Approval FIRST PHASE: Initial Consideration of Plans



- 1. Plan submissions that the Commission had added to the inventory will be placed on a matrix, which will be distributed to each Commissioner for their consideration during a regular meeting.
  - Commissioners will be allotted 10 points each.
  - Commissioners may allocate points to up 10 plans or less, but may not allocate more than one point to each plan.
- 2. The total points assigned to each plan will be tallied during a meeting recess.
  - Upon completion of the tallies, the meeting will reconvene and the 10 plans receiving the most points will be reported to the Commission for further consideration. However, should there be less than 10 plans receiving points, only the number having received points will move forward.
- 3. A two-round discussion period will then be opened. Each Commissioner will have five minutes in the first round, and three minutes in the second-round to discuss the reported plans.

## Map Selection Process & Approval FIRST PHASE: Initial Consideration of Plans (cont.)



- 4. Upon competition of the discussion period, each Commissioner will receive a matrix listing the plans moved forward.
  - Commissioners will be allotted three points which they may assign to any three or less plans on the list.
  - Commissioners are not required to assign all three of their points, and they may not assign more than one-point to a particular plan.
- 5. The Commissioner allocations of points on the lists will be tallied during a meeting recess, and the results will be presented when the meeting reconvenes. The three plans that receive the most points will move forward to the next phase of plan consideration.



## Map Selection Process & Approval SECOND PHASE: Public Hearing



- 7. The Commission holds a public hearing to receive public comment on the maps moved forward from the First Phase.
  - A public hearing is tentatively planned for Saturday, May 21, 2021;
     however, it remains subject to change and could be sooner or later.



### Map Selection Process & Approval THIRD PHASE: Selection of Two Plans



- 8. During the next Commission meeting, Commissioners may amend each of the three final plans by making motions for changes. When a motion is approved, ARCBridge Consulting Inc. will make the approved changes live, during the meeting. The Commissioners will then review the amended maps to assess the resulting impact on the population numbers, compactness & contiguity, neighborhood/precinct and other communities-of-interest boundaries, and packing/cracking.
- 9. After amendments are made, each Commissioner will have an opportunity to discuss their favored map(s), from the top three selected plans, during a two-round debate. Commissioners will get five minutes the first round and three minutes the second round.
- 10.Once the debate is over, each Commissioner will be asked to rank the top three plans from most-liked to the least-liked.
- 11. The two plans that received the most first choice votes move forward, and the remaining plan will be returned to the Commission's inventory.

## Map Selection Process & Approval THIRD MAP SELECTION MEETING: Final Plan Approval



- 12. The Commission will decide if they want to have another public hearing to receive public input. If the Commission decides another public hearing is not warranted, the Chair will ask for a motion for approval of one final map.
- 13. If the Commission decides to hold an additional public hearing, motions on approval of a final map will be made at the Commission's next regular meeting. The Commission will debate the motions via the regular process.
