

1. Public Speakers
 - The Redistricting Commission had 13 public speakers for their April 11, 2022 Redistricting Commission Regular Meeting.
2. Approval of April 4, 2022 Minutes

- The minutes from the April 4, 2022 Redistricting Commission Regular Meeting were approved by the commission.
3. BRIEFING ITEM: Suggested District Maps & Community Recommendations
- ARCBridge Consultants presented a prepared map consolidating a collection of ideal districts created by some members of the Commission. The prepared map showed what the City of Dallas would look like with the incorporated districts that had been submitted, including overlaps, deviations, and population count.
 - Each member of the Commission that had submitted an ideal district presented their priorities that they took under consideration when preparing and submitting their ideal districts for inclusion in the prepared map.
 - General questions related to the map and priorities were asked by the Commission.
4. BRIEFING ITEM: Map Submittal Update
- ARCBridge Consultants provided an update on the total number of maps submitted to-date related to the redistricting process and the criteria they use in reviewing map submissions.
