1. Public Speakers
 - The Redistricting Commission had 33 public speakers for their April 25, 2022 Redistricting Commission Regular Meeting.
2. Approval of April 22, 2022 Minutes
 - The minutes from the April 22, 2022 Redistricting Commission Regular Meeting were approved by the commission.

3. ACTION ITEM: Map Presentations, Discussion & Voting

- The Commission was presented with map submission COD-035 by an individual of the Community. This individual provided an overview of their submission, including changes and what makes their map unique and different.
 - Map Submission COD-035 was not moved into the Commission's inventory for further consideration because no motion was raised to move the submission forward.
- The Commission was presented with map submission COD-040 by a member of the Commission. This Commissioner provided an overview of their submission, including changes and what makes their map unique and different.
 - After a motion and a second, the Commission voted on Map Submission COD-040 and it was moved into the Commission's inventory for further consideration.

4. ACTION ITEM: Selection of Three Preferred Plans

- A matrix summarizing all of the map submissions moved into the Commission's inventory as well as a ballot was distributed to each Commissioner and they were each instructed to select up to their top three maps that they were in support of from the inventory of maps available to them.
- After voting concluded and the ballots were collected, the three map submissions with the highest number of votes were COD-017 with 14 votes, COD-041 with 9 votes, and COD-040 with 4 votes.
- All remaining maps were returned to the Commission's inventory.

5. ACTION ITEM: Selection of Two Preferred Plans

- A second ballot was distributed to each Commissioner and they were instructed to rank the three preferred plans chosen in the previous round of voting in first, second, and third place, with first place being the most supported and third place being the least supported.
- After voting concluded and the ballots were collected, the two maps with the greatest number of first place rankings were COD-017 with 10 first place rankings and COD-041 with 4 first place rankings.
- Map Submission COD-040 was returned to the Commission's inventory.




